Our annual Association meeting will take place on January 25 at 6:30pm at the San Mateo Senior Center, 2645 Alameda de las Pulgas. You will receive a meeting packet in January announcing the meeting and agenda. This is the time when the annual elections process begins. There will be two Board of Directors positions up for election to the 2011-2012 term of service. If you can give a little of your time and energy to help run our Association, please contact PML to submit your name to the elections process. Any Association member in good standing may run for election. The time commitment is to participate in our monthly Board meeting, potentially participate on a committee (landscape, architecture, etc), and a minor amount of homework. We would very much appreciate some new volunteers!

Residential Solar Power:

Based on the likelihood that some owners will be interested in installing solar energy panels on their rooftops in the near future, the Board is developing Sugarloaf policy to guide the Association review process for such architectural changes. A draft policy will be reviewed at the next Board meeting (Dec 21). If you wish to influence the policy, please attend the meeting.

ARCHITECTURAL COMMITTEE

As mentioned in the President's Corner, the Association is planning to address owner desires to install solar power panels. State law prevents associations from outlawing panel installations, but does allow associations to set architectural standards to govern installations. The Board will review (and may approve) a draft policy at the Dec 21 meeting. Please contact Bob Kiss or attend the meeting if you would like to have input on the policy.

LANDSCAPE

During November and December, in addition to regular work, the crew will:

- Trim shrubs at 1913 Parkwood common area
- Leaf cleanup on De Anza sidewalks weekly
- Remove fallen branches along De Anza
- Clean up trash in canyon behind 1817-1821 Parkwood
- Clean up trash in catch basin behind 1901 Parkwood
- Continue to check all catch basins for trash build up

Landscape committee met with an arborist to plan a three-year program to remove and replant dead and dying Pine trees along Parkwood Drive. Phase one will start in January or February 2011.

As a reminder, please do not trim or cut any trees in the common areas. If you have a concern, call PML or talk to a Board member. We have a process to follow in these situations. Thanks for your cooperation.

PUBLIC SAFETY / BARKING DOGS

Please be reminded that owners have a responsibility to keep their dogs from becoming a nuisance to neighbors by their barking (see CC&Rs Section 5.07(a)). Affected owners are requested to work first with your neighbors to address the issue. If that is not successful, you can find more information at the city of San Mateo website, where they provide detailed information on what is needed to file a formal complaint and request for assistance: (http://www.cityofsanmateo.org/index.aspx?nid=272).

Note that it will be very important to carefully document the situation.

TRASH / RECYCLING - PICKUP CHANGE COMING!

As a reminder, starting in January, our pickup day will move to Fridays. We'll be receiving more information from Recology soon to confirm this.

Please be reminded that trash, recycling, and compost containers cannot be placed out for pickup earlier than the day before the scheduled pickup (CC&Rs Sec 5.08). Outside of pickup preparations, containers must be kept out of site per Sec 5.08.

Arrangement may be made for pick-up from your curb of various household wastes including paints, TV's, pesticides, etc. Call 1-800-HHW-PKUP (1-800-449-7587) or email hotline@curbsideinc.com, explain the type and quantity of waste and they will schedule an appointment. The service is included in your garbage fees. You can schedule as many pickups as needed.
